Re: ***Ex Parte* Communication**  
**WP Docket No. 16-261**

Dear Ms. Dortch:

As described in its April 7, 2017 *ex parte* filing in the above-identified proceeding,<sup>1</sup> M2M Spectrum Networks, LLC (“M2M”), accompanied by representatives from the Wireless Infrastructure Association (“WIA”), met with staff of the Wireless Telecommunications Bureau (“WTB”) on April 5, 2017. The *ex parte* filing states that M2M provided WTB with updated information about M2M services. M2M and WIA also reiterated their opposition to the Land Mobile Communications Council (“LMCC”)-proposed, time-limited preference for incumbent licensee access to 800 MHz Expansion Band and Guard Band (“EB/GB”) channels when that spectrum is made available by the WTB,<sup>2</sup> positions those organizations had expressed in comments in response to the LMCC Petition and in the above-identified proceeding. Specifically, the two organizations say they seek “fair and open competition” for that spectrum.

The Enterprise Wireless Alliance (“EWA” or Alliance”) previously has questioned whether the IoT services described by M2M, including in this *ex parte* filing, are appropriate for Part 90 land mobile spectrum. This band is allocated for primary land mobile use, not for fixed applications, and for voice, rather than data, communications. While the Federal Communications Commission (“FCC” or “Commission”) has provided a level of flexibility for

Specialized Mobile Radio (“SMR”) Service licensees operating on exclusive frequencies,<sup>3</sup> it is not clear from the high-level description in these materials that the service being offered by M2M complies with the FCC’s rules. There are a number of alternative bands, both licensed and unlicensed, that are well-suited, likely better suited, for IoT applications, and the Alliance strongly recommends that M2M utilize them for its operations.

With regard to the plea for rules that permit fair and open competition for spectrum, EWA is in full agreement with that objective, as long as the process also promotes the public interest. The Alliance believes that the time-limited proposal in the LMCC Petition appropriately balances those interests for all the reasons it has detailed in the Alliance’s filings in those proceedings.

However, M2M’s call for a fair process raises a further question. Historically, in bands where a limited number of channels are available for assignment on an exclusive basis and the competitive bidding process is not used, the Commission has limited the number of frequencies for which an applicant may apply initially to promote what M2M would call “open competition” for the spectrum. For example, FCC Rule Sections 90.623 and 90.627 limit applicants for 800 MHz conventional and trunked systems to 5 and 10 channels, respectively, in an area. When the FCC opened the “Sprint-vacated” spectrum that initially is available only to public safety entities, it determined that “Due to the limited availability of channels during the period of exclusive eligibility, applicants will not be permitted to apply for more than five channels per fixed location.”<sup>4</sup> FCC Rule Section 90.187(g), governing centralized trunked operations in the bands below 800 MHz, specifies that no more than 10 channels may be applied for at a single site or at sites with overlapping service contours.<sup>5</sup> The LMCC Petition anticipated that resolution of mutually exclusive 800 MHz EB/GB applications submitted by incumbent licensees would be governed by a Memorandum of Agreement (“MOA”) that has been executed by FCC-certified frequency advisory committees – including WIA – with an interest in processing requests for EB/GB channels.<sup>6</sup> That MOA, like the Sprint-vacated standards, proposed to limit applicants to 5 channels initially within an area.

The FCC’s ULS database shows that M2M has entered into leases with large numbers of 800 MHz licensees that acquired EB/GB channels<sup>7</sup> in the generally less populated NPSPAC regions where they have been made available.<sup>8</sup> Attachment A identifies the licenses under

lease to M2M.<sup>9</sup> EWA notes that each of those licenses shows Spectrum Networks Group, LLC (“SNG”), a company affiliated with M2M, as the contact. The Alliance has not checked the ULS history of every leased call sign, but the ones it has checked show that the contact has been modified from Smartcomm License Services, LLC (“Smartcomm”) to SNG. As the FCC is aware, Smartcomm is formally affiliated with both SNG and M2M.

In a proceeding involving several licensees (“Licensees”) whose systems had been leased to M2M, the relationship between these affiliated companies and the Licensees was clarified.<sup>10</sup> These Licensees, seemingly like the others on Attachment A given the number of individuals, trusts and other non-telecom names,<sup>11</sup> had no prior experience in wireless telecommunications and did not seek out SMR opportunities on their own initiative or in a particular market. The Licensees explained that they were solicited by Smartcomm with an offer to prepare and file SMR applications on their behalf and understood that Smartcomm would provide the equipment and site leases needed to meet the FCC’s construction requirement. They subsequently were advised by Smartcomm that it would not provide post-licensing assistance and were referred instead to M2M, which was offering a “hosting” arrangement. The Licensees understood, but claimed they were not able to verify, that M2M built the systems using its own equipment, but then took the systems off the air when the parties were unable to resolve a financial dispute.

EWA has not quantified how many channels M2M is leasing in any market, but in many areas it certainly is more than the 10 trunked or 5 conventional channels permitted under current FCC rules. Therefore, the question is whether it is permissible under those rules for an entity hoping to secure EB/GB spectrum in upcoming NPSPAC regions, when markets like New York, Los Angeles, Dallas, and others become available, to follow the Smartcomm/SNG/M2M approach. Is it permissible for an entity to solicit and then prepare and file SMR applications on behalf of third-party investors with an arrangement, or at least an understanding, that it will undertake the responsibility of building and operating whatever licenses they are awarded and leasing the spectrum from them? The Alliance would have thought that such an arrangement was inconsistent with the FCC’s channel limits and with the concept of “fair and open competition.” If it is not, then all parties interested in EB/GB spectrum should have the opportunity to assemble their own army of applicants and thereby improve their likelihood of obtaining the desired channel position. EWA fears that this “stuffing of the ballot box” will exacerbate the mutual exclusivity problem that was a factor in prompting the LMCC to file the LMCC Petition, but at least the playing field will be leveled and competition will be fair.




